## **INSTRUCTION TO THE BIDDERS**

1. The last date and time of receipt of offer is 5 pm of dt.27.02.2018.
2. A bidder must be in the business of supplying Law Books, Journals & Reports etc. at least for a period of last two years. He (it) must not have been black-listed by any library or organizations by the date of submission of offer.
3. The bidders must provide correct and complete information along with relevant documents in support of the information furnished.
4. Each column / sub column of the form-Annexure-C of prescribed in this Tender, shall be duly filled in with correct and complete particulars / information.
5. The hard copy of the offer document shall be signed by the Principal Officer of the company or, as the case may be, by a partner or proprietor or the Authorized officer or power of Attorney Holder and his / her name and status be stated below the signature under official seal.
6. Each page of all Documents shall also invariably be signed and sealed.
7. The rates shall always be for the latest publication of the Books, Journals & Reports etc. The offer for the latest edition & current year shall always be the preferred choice. Therefore, a bidder needs to ascertain the latest & current position and offer accordingly.
8. If a particular title comes in more than one volume, the number of volumes must be stated in the offer made.
9. Foreign publications (foreign print) will be preferred. However, where Indian Print of a Foreign Publication is offered, it must be marked as “**(IP)**” in the appropriate column.
10. Prices of Indian publications shall be quoted in the INR as usual.

11. In case of a foreign publication, the bidders while submitting offers in **Annexure-C**, must specify the conversion rate of foreign currency at which such purchases is made, in INR with maximum rate of discount in percentage.
12. A bidder shall quote the maximum rate of discount in percentage of the pre-discount price of each Book, Journals & Reports etc. it may choose to offer as Academy will evaluate bids individually for each title and not as per the total titles mentioned in the annexures.
13. Bidders are requested to submit their offers in the form prescribed in **Annexure-C**. The offer along with all documents must be submitted by speed post or courier addressed to %The Director, Odisha Judicial Academy, Sector-1, C.D.A., Abhinav Bidanasi, Cuttack-753014+so as to reach in this Academy by 5.00 p.m. on 27.02.2018. Any offer received beyond the time & date fixed shall not be entertained.
14. The bids will be opened at the first instance before the Purchase Committee at 11.00 a.m. on 28.02.2018 in presence of the bidders / Authorized Agent and shall be evaluated by the Purchase Committee. At the second stage Financial Bids of only technically qualified Vendors / Suppliers will be opened for further evaluation and selection of Vendors for empanelment.

**The hard copy of the offer sent by post shall be accompanied by**

1. A copy of the certificate of incorporation / registration with register of firms.
2. Such documents in support of the number of years, a bidder has been in such business.
3. A self-signed statement that the bidder has not been black-listed by any library or any educational institutions.
4. A copy of the PAN card of the bidder.
5. Any other document, a bidder considers necessary and relevant.
6. The bidders shall have to raise INR bills separately for Indian Titles and Foreign Titles. Also, bills shall carry PAN No. and satisfactory price, proofs of conversion rates etc.

### **Period of Validity of offers for Acceptance**

The offer once submitted shall remain valid for acceptance for a period of 120 (One hundred Twenty) days from the date of receiving of the offer, as stated above. It shall not be open to a bidder to withdraw the offer after submission or vary the rates quoted and /or the terms and condition of offers during this period for any reason under any circumstances.
