Applications along with Bio-data and copies of testimonials are invited from eligible candidates, for two posts of Faculty Members of Odisha Judicial Academy, Cuttack at a consolidated honorarium of Rs.42,000/- per month as per terms and conditions given below to impart training on various subjects of law to the Judicial officers and other participants during Induction / Refresher and other training programmes and to perform such other academic activities as may be required during their tenure. Out of the two posts, one Faculty Member should be a retired District Judge cadre Judicial Officer having experience in teaching/imparting training. The other Faculty Member should be an academician having at least 15 years of experience in the field of Law. The candidates desirous of applying for the post of Faculty Member must be willing to attend the Academy on Sundays/holidays on which training programmes are scheduled to be held.

**Eligibility Conditions:**

- (i) Officers who have retired from Judicial service in the cadre of District Judge on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for engagement against the post of Faculty Member, meant for retired Judicial Officers.
- (ii) An academician having at least 15 years of experience in the field of law shall be considered eligible, for the post of Faculty Member, meant for Academician.
- (iii) Candidates against whom departmental proceedings or criminal cases are contemplated / pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

**Selection Process:**

- (i) Selection of Faculty Members will be made by the Hon'ble Odisha Judicial Academy & Training Committee, High Court of Orissa.

**Tenure, Terms & Conditions:**

- (i) The engagement shall be initially for a period of one year and can be extended for subsequent period with spells of one year each subject to satisfactory performance, up to a total period of four years not beyond the age of sixty-five years of age in any case or till the posts are filled up by regular process, whichever is earlier.
- (ii) Faculty Members so engaged, will be entitled to consolidated honorarium of Rs.42,000/- per month.
- (iii) Retired Government Servants engaged in the post of Faculty Members shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
- (iv) The engagement can be terminated at any time by the appointing authority due to unsatisfactory performance by giving one month notice. On the contrary, if any Faculty Member desires to resign he can do so by giving one month's written notice to the competent authority.

**Last Date for receipt of application:**

The application must be received in the office of the Director, Odisha Judicial Academy, Cuttack on or before 13.08.2023. Any application received after the prescribed last date shall be summarily rejected. An Interview shall be conducted on 17.08.2023 at 5:00 PM by the Hon'ble Judicial Academy & Training Committee at Odisha Judicial Academy for the purpose of selection of above Faculty Members.
