2. The last date time of receipt of hard copy of the offer is dt.28.02.2014.
3. A quotation must be in the business of supplying books, Journals and Reports at least for a period of two years. He (it) must not have been black-listed by any library or organizations by the date of submission of offer.
4. It ought to be appreciated by a quotationer that providing correct and complete information and furnishing the relevant documents in support of the information and furnishing the relevant documents in support of the information furnished are essential.
5. Each column / sub column of the form of offer shall be duly filled in with correct and complete particulars /information.
6. The hard copy of the offer document shall be signed by the Principal Officer of the company or, as the case may be, by a partner or proprietor or the Authorized officer or power of Attorney Holder and his / her name and status be stated below the signature under official seal.
7. Each page of the "Offer Documents" shall also invariably be signed and the seal of the quotation affixed on each page.
